

# Transfer Policy and the PDP



ICANN consensus policy governing the procedure and requirements for registrants to transfer their domain names from one registrar to another.

- Goal: Enhanced domain name portability
  - > greater consumer and business choice
  - registrants may select the registrar that offers the best services and price for their needs
- Went into effect on 12 November 2004
- GNSO reviewed the policy once before, shortly after implementation



#### A phased approach:

### Phase 1(a):

- Form of Authorization (including Rec. 27, Wave 1 FOA issues)
- AuthInfo Codes
- Denying (NACKing) Transfers

#### Phase 1(b):

 Change of Registrant (including Rec. 27, Wave 1 Change of Registrant issues)

#### Phase 2:

- Transfer Emergency Action Contact
- Transfer Dispute Resolution Policy (including Rec. 27, Wave 1 TDRP issues)
- Reversing transfers
- ICANN-approved transfers



- Working Group is currently reviewing Public Comments on the Phase 1A Initial Report.
- During the public comment period, the working group began deliberations on the Phase 1B topics.
- Working Group will return to Phase 1B topics after reviewing public comments on Phase 1A topics and revising the recommendations, as needed.



# Gaining and Losing Forms of Authorization



## Gaining & Losing Registrar Form of Authorization (FOA)



**Gaining Registrar:** The registrar to which the registrant is transferring the domain name.



**Losing Registrar:** The registrar <u>from which</u> the registrant is transferring the domain name.



**Gaining Form of Authorization:** A required form sent by the Gaining Registrar to the Registered Name Holder to confirm the Registered Name Holder's intent to transfer the domain name.

 Typically an email to Registered Name Holder to confirm intent by clicking a designated link. Before GDPR, the transfer could not occur without this confirmation.



**Losing Form of Authorization:** Losing Registrar sends the Registered Name Holder a notice to confirm Registered Name Holder's intent to transfer. Absent objection to the transfer within 5 calendar days, the Losing Registrar processes request.



**Recommendation 1:** The working group recommends eliminating from the Transfer Policy the requirement that the Gaining Registrar send a Gaining Form of Authorization. This requirement is detailed in section 1.A.2 of the Transfer Policy.

**Recommendation 2**: The working group recommends eliminating from the Transfer Policy the requirement that the Registrar of Record send a Losing Form of Authorization.\* This requirement is detailed in section I.A.3 of the Transfer Policy.

\*The working group notes that, in place of the Losing FOA, notifications are sent to the RNH in relation to an inter-Registrar transfer, as detailed in Preliminary Recommendations 3-4.
